## Instructions for Local NMI President's Report

1. Report NMI members who are members of NMI and also your local Church of the Nazarene (Include Adult, Youth, and Children). Give this number to your pastor.
2. Report NMI associate members—members of NMI but not of your local Church of the Nazarene. (Give this number to your pastor.)
3. **Yes** or **No**. If your church is **praying** for global concerns—missionaries, countries, disasters, needs of other people around the globe.
4. **Yes** or **No**. If your church is **discipling** children/youth and adults in mission by inviting them to mission services and encouraging them to explore mission possibilities.
5. **Yes** or **No**. If your church is **giving** 5.5% of your current income to World Evangelism Fund (WEF). Check with your church treasurer and/or pastor.
6. **Yes** or **No**. If your church is **educating** the people by using **all 4 (a,b,c, and d)** areas listed.
  - a.
